### SAIPOL acquires Centre Grains in the port of Sète (34) with the acquisition of AXEREAL's shares and the buyout of minority shareholders

Grand-Couronne, 3 October 2022 - SAIPOL, a subsidiary of the AVRIL group, has completed the acquisition of 100% of Centre Grains, which was previously owned by AXEREAL, SAIPOL and minority shareholders.

Built in 2010, in order to develop the flow of cereals and oilseeds to the port of Sète, Centre Grains is now mainly dedicated to supporting Saipol Sète's activity of processing rapeseed, storing rapeseed intended for crushing, storing protein-rich oilseed cake for export, and storing sunflower hulls used by the biomass boiler that supplies the site's energy.

Each year, Centre Grains manages between 600,000 and 700,000 tonnes of seed flows on behalf of Saipol.

The acquisition of Centre Grains enables Saipol to consolidate its activity in the port of Sète, from the reception of oilseeds to the shipment of products and by-products: vegetable proteins and decarbonated energies. Saipol thus intends to continue the activity and maintain the jobs concerned.

For Christophe Beaunoir, Saipol's Managing Director: "The acquisition of Centre Grains is part of our overall strategy to reinvest in Sète. The perpetuation of these storage capacities on our site, in addition to the reliability of our industrial tools, in which we plan to invest from 2023, anchors our desire to make Saipol Sète a pillar of our development in favour of the decarbonisation of fossil fuels and the supply of proteins, particularly for export."

# **Centre Grains in figures**

  - 17,000 tonne flat storage shed (seeds, oilseed cake, sunflower hulls)

# Saipol Sète in figures
