Specializing in the trade and marketing of dried vegetables (chickpeas, lentils, beans, peas...), it relies on unique expertise in sourcing, serving French and international food industries. With a turnover of 70 million euros, growing thanks to the market's dynamism, and an annual sales volume of 65,000 tons of products, CIACAM positions itself as a key partner in the agricultural and food industries.

Strengthening French supply in a market dominated by imports

In a market where more than 60% of dried vegetables are imported, CIACAM aims to strengthen its French supplies. Faced with the challenges of the sector, this challenge relies on close collaboration with all stakeholders (producer organizations, storage organizations, industrialists). CIACAM aims to base its supply strategy on the agronomic (nitrogen fixation, fertilizer reduction, interest in rotations) and nutritional benefits of legumes.
